TO: Pedals & Paddles Adventure Sports, His Majesty the King in right of the Province of British Columbia, and their directors, officers, employees, instructors, guides, agents, representatives, independent contractors, suppliers, sponsors, successors and assigns (all of whom hereinafter referred to "The Releasees")

Definition: In this Release Agreement, the term "the Activities" means all activities, events or services provided, arranged, organized, conducted, sponsored or authorized by the Releasees including but not limited to: kayaking, stand-up paddle boarding, zodiac boat rides, rental of kayaks, canoes and stand-up paddle boards (hereinafter called "the boats") and other equipment; orientation and instructional courses, seminars and sessions; and all travel, transport and accommodation and other such activities, events and services in any way connected with or related to the Activities.

Assumption of Risks: I am aware that the Activities involve many risks, dangers and hazards. The risks, dangers and hazards include but are not limited to: accidents which occur during transportation or travel to and from the put in; slip and falls while getting into or out of the boats; falling off the boats; overturning out of the boats; loss of balance; impact, collision with or entrapment by trees, logs, deadfall, boats or equipment; hypothermia; changing and inclement weather conditions including storms, high wind, high waves, and lightning; encounters with domestic or wild animals; negligence on the part of other participants; and NEGLIGENCE ON THE PART OF THE RELEASEES, INCLUDING THE FAILURE ON THE PART OF THE RELEASEES TO SAFEGUARD OR PROTECT ME FROM THE RISKS, DANGERS AND HAZARDS OF PARTICIPATING IN THE ACTIVITIES. Communication in the remote terrain which is sometimes used for the Activities is difficult and in the event of an accident, rescue and medical treatment may not be readily available.

- 5. Any litigation involving the parties to this Release Agreement shall be brought solely within the Province of British Columbia and shall be within the exclusive jurisdiction of the Courts of the Province of British Columbia
- 6. I acknowledge that I am personally and financially responsible to return all equipment in the same condition and on time or will be subject to additional charges including repair and lost rental revenue.
