**BY SIGNING THIS DOCUMENT YOU WILL WAIVE CERTAIN LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE.**

**PLEASE READ CAREFULLY**

I am aware that the sports of CANOEING, KAYAKING and PADDLE BOARDING (SUP) involve many inherent risks, dangers and hazards, including but not limited to, changing weather conditions, variations in tides and water conditions, exposed rocks and under-surface obstacles and hazards, the existence of larger vessels on the water, the existence of marine plant and animal life which can be hazardous or poisonous, the failure to operate the canoe or kayak safely or within one's own ability or within appropriate designated areas, negligence on the part of PEDALS & PADDLES ADVENTURE SPORTS or their staff. I am also aware that the risks, dangers and hazards referred to above exist throughout the areas in which I intend to use the equipment which I am renting (herein "the Equipment"). I freely accept and fully assume all such risks, dangers and hazards and the possibility of personal injury, death, property damage or loss, resulting therefrom.

In consideration of PEDALS & PADDLES ADVENTURE SPORTS accepting my application for rental of Equipment and permitting the use of such Equipment, I hereby agree as follows.

1. **TO WAIVE ANY AND ALL CLAIMS** that I have or may in the future have against PEDALS & PADDLES ADVENTURE SPORTS and its directors, officers, employees, agents and representatives, (all of whom are referred to collectively herein as ("the Releasees")).
2. **TO RELEASE THE RELEASEES** from any and all liability from any loss, damage, injury or expense that I may suffer or that my next of kin may suffer as a result of my use of equipment, due to any cause whatsoever,

3. **TO HOLD HARMLESS AND INDEMNIFY THE RELEASEES** from any and all liability for any property damage or personal injury to any third party, resulting from my use of the Equipment.
4. To be fully responsible for and assume all costs, expenses and claims that are a result of any and all efforts involved in the performance of rescue efforts on my behalf and medical attention rendered to me; and
5. That this Agreement shall be effective and binding upon my heirs, next of kin, executors, administrators and assigns, in the event of my death or incapacity.
6. **TO ACKNOWLEDGE** that I am personally responsible for the Equipment and accessories rented to me by PEDALS AND PADDLES ADVENTURE SPORTS and I agree to return the Equipment in the same condition as received, normal wear and tear excepted. I will assume the responsibility to pay for the costs of any damage or loss to the equipment, the rental cost while being repaired or replaced, and loss of value.
